## USER GUIDELINES

Adherence to these guidelines is mandatory.

“**INRIX® XD Traffic Flow Data Archive**” is data from the INRIX Fusion Traffic Flow archive with the capability to access speeds and other information reported at the segment level for specific days and times of day. Data is available at one-minute granularity level in segments that are typically less than a mile. Segments may vary. Data is from 7/1/14 – 12/31/16 in Los Angeles County.

1. **PERMITTED USE.** No INRIX Data will be used in or for any automotive or motor vehicle applications or systems. Under no circumstances will any of the INRIX Data be combined or merged with any other traffic and/or driver services-related data not provided by INRIX, or be transferred to, or used by any competitor of INRIX (directly or indirectly) in any way. Recipient may share with contractors and consultants the user has an agreement with, which includes a confidentiality clause. Use of data shall only apply to the purpose described in the application form.
2. **DATA ACCESS AND USE RESTRICTIONS.** Data will be available through a link until further notice. The recipient will not misrepresent the timing, source, content, or availability of INRIX Data, information gathered from the INRIX Data, or any other information received from INRIX. Recipient shall not publish the raw data in any form that makes it public. Recipient will delete the INRIX Data after the purpose has been satisfied. The purpose is described in the application form. Consultants will only use the data for the sole purpose applied in the application form and must delete after project completion.
3. **DATA ATTRIBUTIONS.** Recipient will at all times display the INRIX logo on any screens (including maps, graphs, etc.) containing any INRIX Data in accordance with the “3rd Party Use of INRIX Logos” guidelines available at [www.INRIX.com/LogoUse](http://www.INRIX.com/LogoUse).
